

# **Terms and conditions of the “Jankowa Polana” Education Room at the C.H. Janki mall**

Prior to entering the room, please read these terms and conditions. Please remember that entering the room means accepting the rules in force in the **Education Room**.

## **TERMS AND CONDITIONS**

### **§ 1**

#### **Access to the “Jankowa Polana” Education Room**

1. The Education Room is located in the C.H. Janki mall, at ul. Mszczonowska 3.
2. These terms and conditions (the “Terms and Conditions”) specify the rules for staying in the Room (also referred to as the “Education Room,” the “Jankowa Polana,” or the “Exhibition”).
3. The Education Room is available to children aged 4 and more, accompanied by their parents or legal guardians. Children have to stay in the Exhibition area under the care of an adult, who is fully responsible for them.
4. The current opening days and hours of the Jankowa Polana are displayed at the entrance to the Education Room.
5. In the event of a breakdown or for other reasons making it impossible to stay in the Education Room, the owner of the Jankowa Polana (the “Owner”) reserves the right to close the Room.

### **§ 2**

#### **Opening days of the Jankowa Polana**

1. The Education Room is open to visitors on the opening days of the C.H. Janki mall.
2. The Room is open to children and the persons taking care of them.
3. Outside of the opening days of C.H. Janki, the Room is closed. The Owner reserves the right to close the Room also on other days.
4. Before entering the room, the visitors have to leave their outer garments in the provided locker and have to remove their footwear.
5. In the event of noticing any inconveniences, the visitors should report them to the mall’s personnel.

### **§ 3**

#### **Visiting the Jankowa Polana**

1. Entering the Exhibition is free of charge.
2. The maximum number of persons allowed to stay in the Room is 20. Please comply with that requirement.

3. Visiting is possible only without footwear (in socks).

#### **§ 4**

##### **Rules of staying in the Jankowa Polana**

With the security of the persons staying in the Education Room in mind and in order to maintain order, the Owner requests that the following rules are complied with:

1. Children under the age of 16 cannot stay on the premises of the Exhibition unless under the care of an adult who is responsible for them, including in terms of the damage to the Exhibition caused as a result of the child's actions.
2. Backpacks, large bags, and outer garments have to be left in the provided locker.
3. Using the mini locker room is free of charge.
4. The Owner of the Jankowa Polana is not responsible for the items left in the locker room.
5. A visitor may enter the Room if they have read and understood these Terms and Conditions and if the maximum number of persons allowed inside has not been exceeded.
6. A visitor may enter the Jankowa Polana any number of times, provided that the maximum number of persons allowed inside has not been exceeded. An exception to this rule is an evacuation caused by force majeure. In such a case, visitors should leave the Room as soon as possible, in compliance with the instructions from the personnel of the C.H. Janki mall.
7. The Owner of the Jankowa Polana reserves the right to restrict visitors from accessing any part of the Exhibition. Such a restriction will be notified, if possible, to the visitors in a manner allowing them to learn this information before planning a visit.
8. The content used in the Exhibition is intended purely to popularize knowledge and culture.
9. The Owner reserves the right to exclude exhibits that have broken down or have been damaged or destroyed.
10. Exclusion of some of the exhibits does not constitute a reason for making any claims to the Owner.
11. While visiting, visitors are required to comply with the requests and recommendations from the personnel of the C.H. Janki mall, the security service team, and the other persons appointed to assist in operating the Jankowa Polana.
12. The stands should be used in accordance with the instructions (if any) found next to the individual exhibits; attention should be paid to the warnings and messages displayed next to the exhibits.
13. The Owner of the Jankowa Polana is not responsible for any events caused by failure to comply with instructions or by using the exhibits incorrectly.
14. The Owner of the Jankowa Polana reserves the right to make claims if an exhibit or another element of the Exhibition is destroyed by a visitor.
15. All of the breakdowns of, damage to, and destruction of the equipment of the Jankowa Polana should be immediately reported to the personnel of the C.H. Janki mall.
16. Persons exiting the Jankowa Polana and their luggage may be inspected by the security service team.
17. Every organized group of minors has to stay on the premises of the Exhibition with at least one adult minder.
18. The minders are responsible for the behavior of their charges and for the losses resulting from them damaging or destroying the exhibits or the other elements of the Jankowa Polana.

**§ 5**  
**Prohibitions**

1. The visitors staying in the Education Room are prohibited from taking any actions that are dangerous for other visitors or the equipment of the Exhibition, as well as from engaging in indecent activities.
2. It is prohibited to:
  - carry away elements of the Exhibition's equipment;
  - move the elements of the Exhibition's equipment outside of their intended locations;
  - destroy the exhibits and interactive stands;
  - use the stands in the Room in a manner other than in accordance with their intended purpose, including by climbing onto devices that are not to be climbed on, scratching surfaces and taking other actions that could damage decorations, leaning against/standing on glass elements, running around the Exhibition, pushing or taking other actions causing other visitors to behave in an unpredictable manner;
  - litter on the premises of the Exhibition;
  - bring dangerous items to the Exhibition premises;
  - bring animals, except for guiding dogs;
  - bring and consume alcohol and smoke cigarettes, including e-cigarettes;
  - bring and use intoxicants;
  - consume food and drinks;
  - bring items that may cause harm to other visitors by soiling or injuring them or by soiling or destroying their property or items that may soil or damage the equipment of the Education Room;
  - operate a business without written consent from the C.H. Janki mall;
  - carry out advertising activities or political agitation without written consent from the C.H. Janki mall;
  - organize gatherings and artistic performances without written consent from the C.H. Janki mall;
  - create a negative impact on the functioning and the image of the C.H. Janki mall;
  - obstruct or block passageways and emergency exits;
  - make it difficult for the members of the personnel of C.H. Janki to work and perform their official duties or to otherwise disrupt the functioning of the Jankowa Polana;
3. Persons whose condition suggests that they have been consuming alcohol or other intoxicants are prohibited from entering the Education Room. The personnel of the C.H. Janki mall and the security service team may remove such persons from the Exhibition.
4. If the behaviors listed in §§ 5(1) to 5(3) take place, the Owner of the Jankowa Polana reserves the right to eject the violators from the Education Room.

**§ 6**  
**Security**

1. The premises of the C.H. Janki mall is covered with a CCTV system for the security of the Visitors; a security service team is also present.
2. The C.H. Janki mall reserves the right to verify if the persons entering the Jankowa Polana attempt to bring in the items referred to in § 5(2).
3. In the event of an evacuation alert, all of the persons staying on the premises of the Jankowa Polana are required to immediately leave the building through the nearest emergency exit and to strictly follow the instructions received from the C.H. Janki mall personnel and from the security service team.

## **§ 7**

### **Use of image**

1. The C.H. Janki mall may use the image of the persons visiting the Education Room who take part in workshops, family meetings, and other forms of education organized by the C.H. Janki mall in the mall's promotional, informational, and documentation materials, unless these persons object to such use of their image.
2. The persons who do not agree to the use of their image or the image of the persons under their care, recorded in the form of photographs, videos, or other recordings documenting the events taking place at the C.H. Janki mall, have to fill out the relevant representation. In the case of a minor, the representation is made by a parent or a legal guardian.
3. Consent to recording the image and to its publication is not required if the photograph or video depicts a general gathering or a public event (a special event, etc.) where different people constitute a detail of the general content of the photograph or video or another form of recording the image of individuals.
4. The personal data of visitors, i.e., their image, will be processed by the C.H. Janki mall. Personal data is processed in order to promote the services referred to in these Terms and Conditions. Contacting the Data Protection Officer is possible via the Owner of the Jankowa Polana.
5. The recipients of personal data will be the visitors of the Jankowa Polana and the persons coming into contact with the promotional materials concerning the activity of the C.H. Janki mall. Personal data will be stored for as long as the Education Room exists. Everyone has the right to demand that the data controller provides them with access to personal data, the right to rectify this data, the right to have it erased or to have its processing limited, the right to data portability, the right to withdraw consent to data processing, and the right to file a complaint with a supervisory authority.

## **§ 8**

### **Final provisions**

1. These Terms and Conditions are available at the entrance to the Jankowa Polana and from the personnel of the C.H. Janki mall.
2. Entering the Education Room means acceptance of these Terms and Conditions.
3. Failure to comply with these Terms and Conditions will be a reason for ejecting the visitor from the Exhibition or for the Owner of the Jankowa Polana to make claims to the visitor in the event of any damage to his property or image.
4. The Owner reserves the right to amend these Terms and Conditions. In such a case, the relevant

changes will be made and publicly announced in the same form.
